WHEREAS, the Wintergreen Property Owners Association is charged with protecting the safety of its citizens and guests, and

WHEREAS, the community of Wintergreen, including Wintergreen Resort, will several times per year have a census exceeding 10,000, and

WHEREAS, the Wintergreen community is located on mountain ridges with only one entry/exit approximately 1,500 feet lower in elevation than the mountain village, and

WHEREAS, the only alternate escape route, which has always been marginal at best, recently became impassable and beyond repair due to a large debris slide, and

WHEREAS, recent fires in Gatlinburg Tennessee have shown what fires in resort communities with similar eastcoast topography are capable of, and

WHEREAS, only 400' of relatively level and relatively sparsely populated forest separate Wintergreen from the Blue Ridge Parkway, and

WHEREAS, Wintergreen Property Owners Association is willing to pay for all costs associated with creating and maintaining an omergancy ingress/egress route between Wintergreen Property and the Blue Ridge Parkway, and

WHEREAS, Wintergreen has for decades been a public safety partner with the National Park Service by providing fire suppression, emergency medical, and law enforcement support between milegost 5 and 25 on the Sive Ridge Parkway, and

WHEREAS, the Virginia Department of Forestry, the Virginia Department of Fire Programs, the Virginia Secretary of Public Safety and Homeland Security, United States Congressman Riggleman, United States Senator Warner, and United States Senator Tim Kaine all fully support the proposed emergency ingress/ogress route,

NOW THEREFORE BE IT RESLOVED that the Wintergreen Property Owners Incorporated Board of Directors supports and authorizes its professional Fire Chief, Curtis N. Sheets, in all endeavors associated with application and approval of a Right of Way granting access from Wintergreen to the Blue Ridge Parkway.
